**REQUIREMENTS FOR THE REPORT  
FORMATTING**

The volume of scientific abstracts is up to 10 pages, text editor – Microsoft Word, orientation – portrait, margins – all 20 mm; font – Times New Roman, font size – 14, line spacing – 1.5.

**The order of submission of conference materials:**

- title of the report (capital letters, bold, centered);
- surname and initials of the author (bold, italics), academic degree, academic title (italics, right alignment);
- position, place of work (study) (italics, right alignment);
- text of the report (width alignment, paragraph indentation 0.7 cm);
- references in the text are made in square brackets – [2, p. 56], where the first digit indicates the ordinal number in the list of references, the second – the page number;
- the list of references is placed at the end of the text under the heading “List of references:” and is formatted in accordance with the requirements for a full in-text bibliographic reference. See the standard “Bibliographic references: general provisions and rules of formatting” (DSTU 8302:2015).
- prohibits quoting in the text and including in bibliographic references sources published in Russian in any country, as well as sources in other languages if they are published in Russia and Belarus.
